DEVELOPING A THIRD GRADE PORTFOLIO*

INSTRUCTIONS**

- Each graded assignment should fit the state mandated portfolio requirements.
- Teachers know the standards and have to include them on lesson plans. This is not extra work for the teacher.
- As long as the teacher can verify the necessary information in the columns, the checklist should apply to any assignments
 or assessments on the computer.

Requirements to meet Florida's statutory requirements of promotion by portfolio***:

- 3 pieces of evidence per Reading standard
- Reading passages must have a breakdown of 60% Literary text, 40% Informational text
- Reading passages must be between 100 words and 700 words, with an overall average word count of 500
- Assessments must be multiple choice.
- Assessments must have a score of at least 70%.

Clusters: No data to be inputted here – heading organize for "Clusters at-a-glance."

Assignment: List title of assignment in this column - should be the same title given in ProgressBook or other assignment source.

Date: List the date the assignment was given.

Standard: Using the key, list the letter of the standards included in the assignment.

Score: Enter the student's score of the assignment. **Word Count:** Enter the word count of the reading passage.

Standard Key: Each of the Reading Standards will have a capital letter for reference.

- In these 4 assignments, there are 2 standards that are assessed 3 times.
- From statute: Teacher and principal sign off that the portfolio is an accurate assessment of the required reading skills.
- The teacher will be familiar with the Standards and will know which of the standards are attached to each assignment.
